1. To consider whether a Member(s) of this Committee would like attend the above appeal hearing and whether any modifications to the original comments are required.

1. Information

- 1.1 Lewes District Council has informed us that an appeal has made to the Department of Communities and Local Government in respect of application LW/14/0150 Former Central Garage, Sutton Park Road requesting approval for the demolition of the former garage building and construction of a five storey building comprising 38 retirement apartments, basement car park, access and landscaping for PegasusLife.
- 1.2 The original application was brought to this Committee on 3rd April 2014 where it was objected to on the grounds of: "going against Seaford Town Policy to turn a commercial property into residential, overdevelopment of the site, significant overshadowin, parking issue in Stafford Road, out of keeping with the local area, and evidence of need for additional retirement properties not demonstrated. Seaford Town Council would prefer a development for mixed use including family and affordable homes. However, if this application was to be approved then we suggest \$106 agreement is drawn up for consideration to highways improvements in Broad Street, Warwick and Avondale Roads, contribution to additional health facilities, contribution towards improvement of open spaces in the town, not just play area provision."

The appeal is to be decided on the basis of an Informal Hearing and I will write again when the date and venue for the Hearing has been arranged.

As an interested party, you are entitled to attend the Hearing, either personally or through a representative and, at the Inspector's discretion, make representations to him. Any comments already made (unless they are expressly confidential) following the original application for planning permission will be forwarded to the Planning Inspectorate and copied to the appellant and will be taken into account by the Inspector in deciding the appeal. Similarly, if you wish to withdraw or modify your earlier comments, or wish to make additional comments, you should write (please send three copies) to the Planning Inspectorate at , Temple Quay House, 2 The Square, Temple Quay, Bristol, BS1 6PN by 20 May 2015 quoting APP/P1425/W/15/3008810. You should note that such representations may well be read out at the Hearing.

The Planning Inspectorate will not acknowledge any comments received unless specifically asked to do so. If representations are received after the deadline they will not normally be seen by the Inspector and they will be returned. If you wish to know the result of the appeal, and would like to receive a copy of the appeal decision letter. whether or not you have made written representations, you should write to the same address, quoting the same reference number.

Letters received by the deadline will be passed to the appropriate Inspector dealing with the appeal and copies will be sent to the appellant and to the Council. The appellant and the Council will each submit statements about the appeal and these can be inspected at my office in due course.

The Planning Inspectorate have introduced an online appeals service which you can use to comment on this appeal. 
