Purpose of Report:

To advise the Committee of East Sussex County Council's

proposals to reduce the speed limit on Steyne Road and

Sutton Avenue and adjacent side roads.

Recommendations

There is no officer recommendation for this item.

1. Information

- 1.1 In 2009, ESCC received a petition asking for the introduction of a 20mph safety zone along Sutton Avenue and Steyne Road, in the area of the three schools and nursery.
- A previous consultation with Seaford Town Council was undertaken in January 2012 where ESCC wanted to proceed with a full time 20mph zone. The proposal was considered by this Committee on 31 January 2013. Members welcomed the proposed 20mph zone with an amendment that is should be a part time speed limit between 8am and 5pm, term time only.
- 1.3 Subsequently, officers of ESCC met with the Chairman & Vice Chairman of this Committee, the Leader & Deputy Leader of the Council and the Town Clerk to advise that a scheme as requested by Seaford Town Council would be too costly and potentially unenforceable.
- 1.4 ESCC advised that the current average speed on the road is 24mph and therefore the STC representatives requested that consideration be given to using the money available in a more strategic way in the town.
- 1.5 Particular areas which were suggested which have speed problems were the A259 in the Claremont Road, Belgrave Road and Beacon Road areas; the A259 at Bishopstone Road, Marine Parade and Hill Rise areas; or the Alfriston Road.



- 1.6 ESCC are now undertaking a public consultation and are specifically consulting with the residents of all roads affected and have presented plans showing two options, both of which would reduce the speed limit to 20mph in the area of the three schools and the nursery.
- 1.7 Option 1 is an advisory part-time 20mph limit operating at the start and end of the school day as shown by the highlighted roads in appendix A attached.
- 1.8 Option 2 is a mandatory full-time 20mph limit operating at all times as shown by the highlighted roads in appendix B attached.
- 1.9 There is no alternative option for use of the money elsewhere in the town.
- 1.10 The consultation period for the local residents closed on 29 November 2013 but the Town Clerk has agreed with the ESCC Officer, Chris Tree, that Seaford Town Council would provide our feedback soon after this meeting.



- 3. To delegate to the Chairman and Vice Chairman of the Community Services
 Committee the authority to agree a final Committee budget for 2014-15 with the Town
 Clerk and Support Services Manager, taking into account the comments of this
 Committee.

1. Information

- 1.1 The draft projected outturn for the current financial year and the proposed budget for 2014-15 is attached to this report as Appendix A.
- 1.2 The following comments should be considered when reviewing this report. There are also some notes specific to the particular line item.
 - (a) Tree Warden Expenses were moved to Community Services in 2012/13.
 - (b) Projects Budget was allocated for additional grit bins which can be met from earmarked reserve.
- 1.3 Items suggested by Members for inclusion in the budget will be presented to the Council meeting being held on 16 January 2014 to approve the budget. Currently a suggestion of an additional bus shelter on Walmer Road has been suggested.



- 1.4 Following discussion with the Chairman & Vice Chairman of this Committee and the Leader & Deputy Leader of the Council it is recommended that as this Committee has such a small budget allocation that these items be reallocated to the Community Services Committee and that the proposal be passed to Finance & General Purposes Committee for agreement.
- 1.5 As this is the last meeting of this Committee before the budgets have to be finalised it is recommended that Members pass comments to the Chairman and Vice Chairman of Community Services Committee, subject to agreement of the above recommendation, and authorise them to agree the final budget with the Town Clerk and the Support Services Manager.
