Marjery Diamond Regarding Item 6 on the Agenda, requesting that the

> Council support option 2; the mandatory, full-time 20mph speed limit on Stevne Road/Sutton Avenue as per the highlighted roads in Appendix B. Option 1 is fine in principle but in reality with signs only outside the actual schools, this will not provide as much protection. This proposal differs from other speed restrictions in the town as it is directly addressing a

risk to children and vulnerable adults.

Mr Gower Questioned the costs involved with implementing the

options in Item 6 and how the Police will regulate

the speed limit.

Town Clerk An exact cost has not been calculated for

implementation. The S106 has granted £70k to be

spent on the scheme. If police enforcement is

required, this would be prioritised among other areas by the Police. There is also a designated voluntary

speedwatch site on Sutton Avenue.

# P&H 58 20mph Scheme - Steyne Road/Sutton Avenue, Seaford

Members considered report 119/13.

The Town Clerk clarified the meaning of information point 1.9; it states that there is no alternative option for the use of the money elsewhere in the town, meaning there was no alternative option put forward by East Sussex County Council within the proposal for alternative use of the money.

ESCC have had 800 responses to the consultation:

71% support a 20mph limit

### Support of options:

- 1 advisory part time 29%
- 2 mandatory full time 49%
- 3 no preference 2.5%

4 – neither 18%

5 – did not answer 1.5%

The next step will be for ESCC to analyse the responses by post code. More weighting will be given to those respondees that live closer to the areas in mention.

It was relevant to include these figures in today's meeting so it is in the public domain as the Committee having been reported to.

It was AGREED to SUPPORT option 2 as a full-time, mandatory speed limit.
