Planning Permission LW/652/CM

#### Recommendations

You are recommended:

1. To consider comments on the proposed variations and respond to ESCC.

#### 1. Information

- 1.1 ESCC are considering planning application LW/696/CM in respect of Unit 3, Cradle Hill Industrial Estate.
- 1.2 The application proposes a variation of conditions 5 and 8 of planning permission LW/652/CM to allow the storage of empty skips in the yard to the south of the building. Condition 5 stated that no items should be stored outside the building, other than empty skips stored within areas A + B to the north of the building. Condition 8 stated that the area to the south of the building should not be used for any purpose associated with the use being permitted other than pedestrian access to and from the building, unless otherwise agreed in writing by the Director of Transport and Environment.
- 1.3 In 2009 when considering the original application (permission granted in September 2009) this Committee objected to any outside storage. A subsequent application was made in 2011 resulting in permission LW/652/CM being granted which then allowed outside storage on the north side of the building, they are now seeking permission for storage on the south side.
- 1.4 The application also requests retrospective approval for alterations to the main site entrance and construction of metal fencing and gates at the front of the site.
- 1.5 The application further requests approval of the use of a Telehandler inside the building to help with the loading and unloading of waste.



- 1.6 The notification was received on 7 September with a requested response by 12 October.
- 1.7 A copy of planning permission LW/652/CM is attached to the application for reference.
