**CS 42 Minutes**

The minutes of the meeting held on Thursday 28 November 2013 were **AGREED** as a correct record and signed by the Chairman.

**CS 43 Public Participation**

*Mr Brown* *There are only two items on this agenda and this agenda is a lot shorter than the agendas for Community Services Committee back in 2011.*

*He understands that there will be a change in maintenance for parks and gardens and the new contractor will be based in Redhill, he asked if this was correct.*

*Commented on South Hill Barn and when he was the Chairman of the Community Services Committee back in 2010 it was in progress to do something with it, has any further thought been given since then?*

*Mr Brown also asked if regular meetings regarding the beach and promenade are still being held.*

*Mr Brown asked for an update on whether beach huts will be put in at Bönningstedt Parade, this was put forward following the redevelopment of Beach Huts at Martello.*

**CS 45.2** It was **AGREED** to **DELEGATE** authority to the Projects & Facilities Manager, in consultation with the Chairman of this Committee and Seaford Head Advisory Group where required, to provide the final approval.

**CS 45.3** It was **AGREED** to **REQUEST** that the applicant explores the possibility of Chalvington Fields, the former 'North Camp' being considered in these studies.
