Purpose of Report:

To consider assisting East Dean & Friston Parish Council in

asking East Sussex County Council to consider traffic

management improvement at Exceat Bridge.

Recommendations

You are recommended:

1. To consider whether or not to join East Dean & Friston Parish Council in asking ESCC to consider traffic management improvements at Exceat Bridge.

1. Information

- 1.1 Seaford Town Council has received a letter from East Dean & Friston Parish Council explaining the traffic problems arising at Exceat Bridge during large events and at peak traffic periods.
- 1.2 The letter explains that they have expertise within their Council to prepare a detailed report setting out the issues with a view to asking East Sussex County Council to consider traffic management improvements at the locus.
- 1.3 East Dean & Friston Parish Council would very much welcome Seaford Town Council's views as a neighbouring Council as to whether we consider that such a document would be worthwhile and whether we would be prepared to join them in lobbying for improvements.
- 1.4 At a previous meeting of this Committee held on 13 March 2014 where members were asked to consider prioritisation of road schemes for the town, it was agreed that the prioritisation be given to a crossing on the A259 in the vicinity of Claremont/Belgrave/Beacon Roads in Seaford and Speed Reduction in the Bishopstone Road area on the A259. The two other proposed road schemes, a crossing on Belgrave Road near the junction of Kingsmead and installation of double yellow lines from the cemetery gates in Cradle Hill Road and cross the junction of Valley Drive are left for the time being.



1.5 Consideration of whether the above schemes are more of a priority than that of the traffic management improvements at Exceat Bridge should be taken into account before a decision to assist East Dean & Friston Parish Council is made.

Purpose of Report:

To consider the prioritisation of a crossing at Edinburgh

Road.

Recommendations

You are recommended:

1. To consider the prioritisation of a crossing at Edinburgh Road.

1. Information

- 1.1 Seaford Town Council has received a report from Seaford Community Speed Watch Group informing that they took up an appeal in March on behalf of the residents of Marine Parade, Seaford asking ESCC to implement a simply marked crossing near the Edinburgh Road entrance to Marine Parade.
- 1.2 Seaford Community Speed Watch Group received a response from Rupert Clubb of East Sussex County Council informing that following a review of an assessment of the priority for the scheme, the outcome of the review is that a formal crossing facility still does not rate as a priority as part of their Capital Programme for Local Transport Improvements at this time.
- 1.3 However, it was recognised that even though some schemes are not a priority to be delivered using County Council resources, they are still none the less of great importance to the local communities and that therefore ESCC are developing a Community Match Initiative to provide local communities the opportunity to help themselves and take forward these transport improvements that are of local importance.
- 1.4 The committee is asked to consider whether this scheme is a high priority and whether it would be a scheme that should be promoted as a community project through this new initiative.



1.5 The Committee should also take into consideration previous proposed traffic calming road schemes that have already been prioritised at a meeting held on 13 March (also mentioned in report 63/14 of this meeting).

2. Financial Appraisal

- 2.1 There are no direct financial implications as a result of this report.
- 2.2 Seaford Town Council would be required to either fund the works or gain match funding in order for the scheme to go forward.
