P&H 26 Apologies for Absence and Declaration of Substitute Members

Apologies for absence were received from Councillors S Dunn and I White.

P&H 27 Minutes

The minutes of the meeting held on 08 August 2013 were **AGREED** as a correct record and signed by the Chairman.

P&H 28 Disclosure of Interests

Cllr R Allen declared he had an interest other than a pecuniary interest in application LW/13/0514 and LW/13/0515 as he is a member of the Seaford Museum and Heritage Society.


P&H 29 Public Participation

Christine Latham Drew attention to the parking problem on Station Road, Bishopstone and produced photo evidence. Would like an urgent review of the situation that is now becoming a dangerous issue as emergency vehicles would not be able to get past.

Chairman This is an on-going problem and should be an ESCC matter.

Town Clerk Clarifies that STC did not remove from the Atkins Report and as previously advised to residents, advised that this matter is with ESCC.

Mr B Brown Following a recent serious accident at the junction of Church Street and the High Street, it is of great concern that the current road layout gives way to lighter traffic already slowed down by speed bumps and would like the right of way restored as it was some years ago.

Town Clerk This is not an issue to STC but an ESCC issue. 

Mr B Gower *Asked if an item relating to an accident at Bishopstone Road can be added to the SLR agenda.*

Town Clerk It is not for the public to request that items be added to the SLR agenda as this is not a public meeting. It is suggested that Mr Gower directs this question at ESCC.

P&H 30 Planning Applications

Planning Applications week ending 2 August 2013

The Chairman Advised that two items from W/E 16 August have been left off the Agenda and that these will be discussed at the next meeting.

LW/13/0500 Planning Application – remove hanging tiles on side of property and replace with white render with black border for Mr S Slade

Recommend approval as it improves appearance of the site and gives unity to the building.

Seaford **Re-advertisement – Amended Description**
LW/13/0306 **11 Blatchington Road**
Outline application for demolition of a vacant commercial unit and garage and erection of a terrace of three 3 bedroom houses for St James' Trust.

Maxine Dunaway Resident of Richmond Terrace, a private road, the cost of maintenance and repair of the road falls on all residents. Although no objection to the housing itself, there is concern of increased traffic, safety & signage and in terms of construction the road is not adequate. Can the residents and the council work together in maintaining the road and safety issues.

Town Clerk The Committee can only deal with planning issues and suggest that this is a legal issue to be dealt with by a solicitor.

Objection – on the grounds of effect on highway and traffic, overdevelopment of area and conversion of commercial site in the town to residential.

Members commented no as it sounds like flooding of Cuckmere by the back doors.


Question 4: Do you agree with our proposed approach to minerals safeguarding and safeguarding wharves and railheads?
