



- 1.1 A notice has been submitted by Mr Ian Fears for Seaford Royal British Legion requesting that parts of Avondale Road, Sutton Park Road, Broad Street and Place Lane be closed on 8 November 2015 to facilitate the Remembrance Day Parade. The event begins at 10.30.
- Avondale Road will be closed surrounding the War Memorial, Sutton Park Road from junction with Avondale Road to Broad Street, Broad Street from Sutton Park Road to junction with Place Lane and Place Lane Seaford. The closure will be in effect between 10.30 and 11.20 on that day. A map detailing the area to be closed is attached as Appendix A.
- 1.3 The proposal has not yet been discussed with the Police, however the Police ordinarily assist this event with the covering of the road closures and have regular meetings with Royal British Legion.
- 1.4 The road closure will affect the bus route.

- 1.6 This is an annual event.



### 1. Information

- 1.1 It was brought to our attention that an East Sussex County Council (ESCC) planning application relating to Cradle Hill, Mobile Classroom was not received by Seaford Town Council (STC) or Lewes District Council (LDC).
- 1.2 ESCC noted that they had received no response from STC when this item was put before their committee on 22 July 2015.
- 1.3 On further investigation, Amanda Parks of ESCC stated that the original application had been sent to both STC and LDC on 29 April 2015, although it has now been realised that the plans were not received by either council.
- 1.4 As LDC did not receive the information, it was not but on the weekly lists which meant STC were totally unaware of this application.
- 1.5 It was questioned to Amanda Parks as to why this may have happened and was informed that they seemed to have an issue with their post that day and that it was a glitch in the system but such errors should not happen in future.
- 1.6 This does mean however, that STC were unable to give their comments on this application.
