The Mayor welcomed Colin Andrews and Isabelle Mouland to their first Full Council Meeting.

C80/10/18 Apologies for Absence

Apologies for absence were received from Councillors B Burfield, T Goodman, A Latham, B Webb, C White, and Young Mayor Dominic Avey.

C81/10/18 Disclosure of Interests

No declarations were made of discloseable pecuniary interests or interests other than pecuniary interests as defined under the Seaford Town Council Code of Conduct and the Localism Act 2011, in relation to matters on the agenda.

C82/10/18 Public Participation

Comments on Agenda Item 8, North Way Land Petition

Resident A Expressed concern about the land sale which will result in a loss of green

space. Feels that the Councillors did not make an informed decision as they had not received all the facts about the use of the land. Highlighted that green spaces are vital to health, both mental and physical, that it would not be fair to develop the land and that residents will continue to oppose

development.

Resident B Explained how the proposed development will block access to their house

and that legal steps are being taken to investigate and hopefully stop this from happening. The proposed development will cause traffic and parking problems and is not in keeping with surroundings due to much smaller

outside space of properties and shared driveways.

Resident C Unacceptable that Seaford Town Council is hiding behind its petitions

policy when other authorities review petitions with a lower threshold. The Town Clerk had not been aware of s52 agreement but carried on with process after it was brought to his attention. The re-routing of the footpath is fundamental but has not yet started. Urged the Council to leave the site

as intended.

Resident D Concerned that the Council is being mislead about the use of the land and

that it is not just used as a cut through, it is used for outside play.

Comments on Agenda Item 9, Neighbourhood Plan

Resident E

Discussed North Way Land Sale, supported the above comments from residents adding that Seaford lacks green corridors and this should be looked at by the neighbourhood plan review group. Concerned the existing Neighbourhood Plan Steering Group is not meeting in public and the meeting minutes are not available to the public.

Resident F

Within the draft Neighbourhood Plan there are over 100 units that have been reserved but adequate sewerage and gas needs to be in place. Other sites have been reserved by their owners who have no intention of building. The resident had offered the Council its eastern land which is a brownfield site ready for development.

Resident G

Comments on item 10a, proposals for trade huts. Asked the Council to consider –

- a more secure license agreement to make concessions feel more 'safe' and able to develop businesses;
- let huts be available all year round for those that want to continue trading and make them more affordable;
- keep the initial agreement as this worked very well.

Town Clerk

Cannot see a problem with the huts being available all year round if there is a demand, however will need to consider weather. Unfortunately, concession agreements can only be short term, this is a risk that comes with being a concession. Rates and agreements with concessions must be fair and consistent with all traders.

Members discussed: the recommendations from the former RFO to include financial implications in Council/Committee reports; and the possibility of a database of leases showing when they are due for renewal to keep councillors informed.

C87/10/18 District / County Councillor Update Report

Lewes District Council -

The most recent copy of the District News has been distributed and includes the £18m Health Hub go ahead which awaiting the next plans and a note about a future email survey which will investigate needs for electronic car charge hubs.

It was advised that a recent BBC Sunday Politics show implied that proposals for Lewes District Council and Eastbourne Borough Council to become a Unitary Authority were set proposals. This is not correct and there had just been discussions. There have been complaints regarding services following the merge of Lewes District Council and Eastbourne Borough Council, people are encouraged to continue to let Lewes District Council have feedback where necessary.

East Sussex County Council -

Members received updates on the following items: Gatwick Airport plans have been announced; the survey on Exceat Bridge has started; the music service has been saved; and following complaints about traffic in the Cradle Hill Primary School area there is a traffic plan being worked on with the School.
