# F21.1 Receipts, Payments and Bank Reconciliation for November 2017, December 2017, January 2018 and February 2018

The Committee considered report 141/17 advising of receipts, payments and bank reconciliations for November and December 2017 and January and February 2018.

- F21.1.1 It was RESOLVED to NOTE (as previously reported) the balance brought forward from October 2017 is £450,449.62.
