# 1. Background

- 1.1 As part of its objectives to develop and increases its public engagement, East Sussex Healthcare NHS Trust (ESHT) approached the Council with an offer to attend one of its meetings and provide information on how they are improving the quality of care and to invite views on what else could be done to improve patient experience.
- 1.2 The Council welcomed this offer but wished to also invite the NHS Eastbourne, Hailsham and Seaford branch of the Clinical Commission Group (CCG) to attend.
- 1.3 The 'NHS' locally has two main strands; the service provider (ESHT) and the statutory body (CCG) responsible for the planning and commissioning of health care services in the area.
- 1.4 ESHT provides the acute hospital and community health services for people in the county, including locally Eastbourne DGH, Hasting Conquest Hospital, Lewes, Crowborough and Uckfield Hospitals, and Seaford Medical Practice. ESHT employs around 7,000 staff, has about 700 inpatient beds across its sites and serves the population of East Sussex which numbers around 525,000.

CCGs were created in 2012 following the Health and Social Care Act coming in to force. CCGs strive to get the best possible health outcomes for the local population, by assessing local needs, deciding priorities and strategies, and then buying services on behalf of the population from providers such as ESHT. CCGs are responsible for the health of their entire population, and are measured by how much they improve outcomes.

East Sussex is formed of three separate CCGs; healthcare in Seaford is covered by the NHS Eastbourne, Hailsham and Seaford CCG.

This meeting will be attended by Graham Griffiths, Director of Performance & Delivery, and Chan Maher, Community Relations & Membership Engagement Officer, of the CCG and by Ruth Farre, Engagement and Communications Officer for ESHT and a ESHT Board Member who is yet to be confirmed.



- 1.6 ESHT will look to provide the meeting with an overview of how it is undertaking improvements, followed by welcoming questions from councillors and members of the public, should they wish to.
- 1.7 The CCG representatives will also be present as the decision makers regarding healthcare in the area.
- 1.8 This meeting is an opportunity for the Council and local residents to engage with both ESHT and the CCG regarding the local healthcare services.
