C 27 Apologies for Absence

Apologies were received from Councillors S Dunn and S McStravick.

C 28 Minutes

C 30 Public Participation

Keith Blackburn

Read a statement on behalf of the Seaford Community Partnership on communications with Seaford Town Council. Mr Blackburn voiced his frustrations at not being allowed to access seafront proposals. He believed that Councillors should be made aware of the results of the public consultation exercise from the Seafront Exhibition held in March before their visioning meeting and to know what the Community Partnership suggested is the way forward.

Councillor Ian White thanked Mr Blackburn for his statement but disagreed with the points that he had made. He believed that Councillors should undertake visioning exercises with an open mind, and not with predetermined ideas and that Mr Blackburn had had numerous and lengthy meetings with Council Officers.

The Town Clerk asked that Mr Blackburn follow proper channels in distributing information to Councillors, ie through the Council and not through individual Councillors and stated that she had asked for the information that he referred to at a previous meeting, but it had not been forthcoming.

Bob Brown

Mr Brown notified the meeting that Southern Water had repaired the railings at Splashpoint and had also repaired a drain at Blatchington Road. The Kittywake Watch had now been cut down to around six days watch due to cutbacks.
