C 37 Apologies for Absence

Apologies were received from Councillors S Adeniji, S Gauntlett, T Goodman, P Heseltine and A Latham.

C 38 Minutes

The minutes of the meeting held on 13 June 2013 were **APPROVED** by Council and signed by the Mayor.

C 39 Public Participation

*Letter from E.Hill
read by the Mayor*

He attended the Mayor's Civic Service at Seaford Baptist Church on 7 July 2013, where local dignitaries were invited. He mentioned that there was a lack of support from councillors at the event as only six Councillors attended plus the Deputy Mayor. Councillors should support the Mayor in the future for all Seaford Mayor's events.

Kevin Gordon

Thanked the Council for the support with the Museum. He also commented on the new yellow lines that have been put outside the museum and said that he supported the new yellow lines. The yellow lines in front of the toilets by the museum he did not agree with as the disabled and taxi drivers parked outside them regularly to easy accessibility. Also the Museum had not been advised of the lines going onto The Esplanade as they have a PO BOX address and letters did not get sent to PO BOX addresses and the signage in the area only said yellow lines would be put out on Marine Parade. Can the Council change the yellow lines outside these toilets?

Town Clerk The yellow lines were put outside the toilets at the request of the Town Council as was causing damage to the shingle areas. A disabled bay has been marked out in front of the toilets that could fit two cars. The yellow lines have been put in front of the toilets because it is not a safe due to way the road runs, Seaford Town Council could request to change the yellow line.

Mr Brown Requested an update on the new golf clubhouse

Item 9 – SDNP – page 59 – This will cause a lot of controversy and asks councillors to dwell on the fact whether the Pevensy levels should drain into the Cuckmere in future.

Raised a road safety issue at the bottom of Church Street at the junction where it meets the High Street. It is a very dangerous junction where today someone had an accident. There are no speed controls in Church Street and frequent accidents are occurring.

Members considered report 60/13


It was **RESOLVED** to **DELGATE** authority to the Town Clerk in consultation with Councillors, M Brown I White and R E Allen to respond to the consultation.
