C 46 Apologies for Absence

C 47 Minutes

C 48 Public Participation

Christina Latham Asked if the Council was aware of any planning applications submitted
to Lewes District Council to develop the Buckle car park into flats.

Town Clerk Seaford Town Council have not received any notifications of any
planning applications from Lewes District Council to develop the area.

Mr Foxwell Item 9 on the Agenda - Representation of Outside Bodies; the Coastal
Futures Group 2150 needs a Councillor as a representative.

Town Clerk The Coastal Futures Group has always had representation from a
Councillor; it was Cllr T Goodman and Cllr M Brown previously.

Cllr C Lambert Alongside Carol Edwards, Think School Travel.
(East Sussex Requesting support from Seaford Town Council on a petition that has
County Council) been presented to East Sussex County Council (ESCC) regarding safe
crossing over Belgrave Road. An offer of support has been negotiated
from ESCC to work alongside Seaford Town Council to gain funding
for this. This would not be an ongoing cost to the Council. A physical
copy of the petition was passed to the Mayor.

Cllr I White

Various meetings have been held with ESCC to discuss the safety in town. Seaford Town Council's view on crossings is that it is more important to have a crossing on the A259 at Belgrave Road, then at Hill Rise or Bishopstone Road, than have a crossing in a back road. The Council understands the concerns and has looked at the plans, but cannot install a crossing from a pavement to a grass verge.

Town Clerk Seaford Town Council has been raising issues regarding the allocation of funding of open spaces for a long time, as Seaford residents continue to supports assets not only in Seaford but also other areas. The Leader of Lewes District Council has said, further to the proposal being made to seek fairness in the funding of open spaces, that the response from areas not affected by the increase has been poor but the areas that are affected, namely Lewes and Newhaven, has been better.

Seaford residents would potentially see a decrease in the District Council figure of the Council Tax. Other towns could potentially take on their open spaces, giving a baseline of Council Tax for the district. Council Tax demands would have a new 'Special Expenses' row added.
