C80/01/20 Civic Reports – Young Mayor’s Update

The Young Mayor provided a verbal update on her fundraising since September 2020; she has raised over £1,200 from activities such as a 30 mile bike ride, a raffle and an auction for a voucher for ‘etch’ the Brighton restaurant owned by Masterchef winner Steve Edwards. The Rotary Club also kindly donated £100 to her fundraising; she hopes to use this to obtain an in-demand piece of clothing to then hold a raffle to win.

C81/01/20 Climate Change Working Group Update Report

The Town Council considered report 120/20 presenting the update report from the Town Council’s Climate Change Working Group and the recommendations within.

The Chair of the Working Group introduced the update report of the Group and took questions from members. The Clerk explained that a further update report will be presented to the next Full Council meeting and Officers are clarifying the arrangements for the Seaford Community Partnership Lottery Project sub-groups.

C81.2 It was **RESOLVED** to **AGREE** that the Council acknowledges that having declared a Climate Emergency last year the Council now has a duty to take action with initiatives that will address the dangers that the town faces through Climate Change impacts.

C81.3 It was **RESOLVED** to **AGREE** to host a day or weekend on The Salts to inform and educate residents about the impacts of Climate Change locally and how the community can prepare and act to lessen these impacts. It is suggested this be planned for July/August, COVID-19 developments allowing.

C81.4 It was **PROPOSED** to **AGREE** that the purpose of the Climate Change Working Group be amended to ‘*Considering and ongoing monitoring of the climate change situation in town and bringing forward recommendations for climate change actions/amelioration measures; reporting back to Full Council as and when required*’; this **MOTION** was **CARRIED**.

C82/01/20 District & County Councillor Update Report

Cllr Christine Brett, Lewes District Council –

Informed the meeting that Lewes District Council had recently announced that its green waste bins could only be paid for by online system, which caused issues for residents. This has now been rescinded and residents should receive a letter about telephone payments still being available.

C86/01/20 Full Council Draft Budget 2021/22

The Town Council considered report 118/20 presenting the Full Council Draft budget for 2021/22 and projected budgets to 2025/26.

The RFO introduced the report and clarified a small change to the figure for the Salts tennis courts project. Members discussed the precept setting in great depth.

C86.1 It was **RESOLVED** to **SET** the 2021/22 Precept at £984,150 and a Band D of £104.06.

C86.2 It was **RESOLVED** to **NOTE** the Projected budgets for the years 2022/23, 2023/24, 2024/25 and 2025/26.

C86.3 It was **RESOLVED** to **AGREE** to budget to add at least £100,000 per annum to the General Reserve until the General Reserve is at least £500,000 or equal to 50% of the Precept, whichever is the higher.

C86.4 It was **RESOLVED** to **APPROVE** expenditure budgeted to and from Earmarked Reserves as set out in 2.7 of report 118/20.


C89/01/20 Councillor Communication Methods
