The Mayor moved that:

'Further to his time in office as the Mayor of Seaford, Seaford Town Council wishes to remember and record its gratitude to Councillor Rodney Reed for his commitment whilst Mayor of Seaford for the last two Municipal Years.

Councillor Reed took on the role of Mayor of Seaford at a particularly challenging time, with the country having just entered into a national lockdown. Councillor Reed embraced the challenge and helped steer the Town Council through the Covid-storm, whilst also

upholding as many of the civic aspects of the role that were allowed at the time. Councillor Reed navigated the demands of the role expertly, despite being the Town Council's first 'virtual Mayor'!

Thankfully, with the easing of restrictions in 2021, Councillor Reed was able to experience the role of Mayor as it is more traditionally known and has since attended over 50 events and functions, helping maintain and raise the profile of Seaford Town Council in its local and neighbouring communities.

Councillor Reed hosted events including the Mayor's Civic Service and Mayor's Carol Service, as well as being heavily involved in helping facilitate a number of community and Town Council events.

During his time in the mayoral office, Councillor Reed set up the 'Mayor's Charity Initiative' supporting 36 local charities and more recently, led a project looking at improving the availability of life-saving defibrillators within the town.

The Town Council also extends its gratitude to the Mayoress, Ann Reed, who has supported the Mayor throughout the past two years – including playing the piano at the Mayor's Carol Service!

On this day, the 12th May 2022, Seaford Town Council thanks and honours Councillor Rodney Reed for his service and achievements as the Mayor of Seaford.'
