C21/05/22 Town Clerk's Update Report

C27/05/22 NALC Survey – Direct Funding for Local Councils

The Full Council considered report 11/22 seeking Full Council's comments on a survey being run by the National Association of Local Councils on direct funding for local councils from central government.

Members discussed an example of having to approach both the District and County Councils to ask for a share of funds it had received from central government, the possibility of restrictions being imposed as a result of central funding and the differing financial requirements depending on size of the town or parish council. Members expressed their agreement with it being clear that there are clear and fairly balanced pros and cons of town and parish councils having access to direct funding.

It was **RESOLVED** to **NOTE** the report and the comments raised by members during the meeting to inform Town Council Officers submitting a response on the Town Council's behalf.
