Reason for Exemption: to discuss confidential membership and debtor matters.

**Explanation of Reason:** under Data Protection and Freedom of Information legislation, information about the financial arrangements and activities of a business or individual must remain confidential between the parties involved.

It was **RESOLVED** to **APPROVE** the cancellation of a 7 Day Membership for Golfer A from 1<sup>st</sup> August with no further costs and to **WAIVE** the defaulted July direct debit payment.
