South Downs National Park Application

SDNP/21/02342/FUL – Exceat Bridge, Eastbourne Road, Exceat - Realignment and replacement of an existing single lane bridge at the A259 over the river Cuckmere, with a new two way, two lane bridge with a footpath, including reprofiling of the river and road embankments. Proposed provision of traffic calming measures between the Seven Sisters Country Park and Seaford. Alterations to access and provision of shared surface to east of Cuckmere Inn. Provision of a habitat creation area to restore agricultural land back into wetland on the east bank of Cuckmere Valley. The application is supported by an Environmental Statement.

<u>LW/22/0630</u> - **1 Norman Close, Bishopstone** - Single storey side and rear extension for Ms S Carroll.

LDC Planning Applications received in week commencing Monday 3rd October

<u>LW/22/0644</u> - **5 Manor Road** - Installation of 2no dormers to front, 1no dormer to rear, 1no dormer to side and alteration to fenestration on all elevations for Mr & Mrs N Patel.

<u>LW/22/0647</u> - **12 Quarry Lane** - Installation of rear balcony with glass balustrade to existing flat roof for Mr & Mrs P Smith.

<u>LW/22/0634</u>- **42 Rookery Way Bishopstone** - Increase in height of roof pitch to create an additional storey, first floor single storey extension to front, installation of 1no dormer to front and 1no dormer to rear and alterations to fenestration on all elevations for Mr A Scotcher.

Note: This is an application for full permission following the refusal by Lewes DC of an earlier application for Prior Approval. The grounds of objection of both STC and LDC were that the increase in height would form an incongruous and unsympathetic visual feature within the setting of the National Park and would be unsympathetic to character of surrounding area. The applicant has appealed against LDC's refusal of Prior Approval.

<u>LW/22/0652</u> -17 Kingsway - Erection of single storey rear extension, rendering and recladding to front for Mr & Mrs D Jordan.

<u>LW/22/0548</u> - Seaford Community Fire Station, Cradle Hill Road - Variation of Condition 1 (Plans) in relation to approval LW/21/0979 to increase building length by 1m and reduction in height for Mr Mark McCorkell.

TW/22/0083/TPO - 7 Seagrove Way - Proposal: T1 - Elm tree - Crown Thinning 40% T2 - Elm tree - Crown Thinning 40% T3 - Sycamore - Crown Thinning 40% due to large falling branches T4 - Sycamore - Crown Thinning 40% due to large falling branches T5 - Sycamore - Crown Thinning 40% due to large falling branches for Mr N Dickerson.

TW/22/0077/TPO - 12 May Avenue Seaford - Proposal: T1 - Corsican Pine - remove major deadwood. T2 - Sycamore - crown thin by 20% and crown lift to 2.5 metres T3 - Sycamore - crown thin by 20% and crown lift to 2.5 metres Work being undertaken forms part of a cyclical pruning regime for Mr S Cox.

TW/22/0080/TPO - Russet House, 46 Firle Road - Proposal: 5 large Sycamore trees; Tree 1 (rear garden) reduce length of lowest north facing branches closest to the building by 4-5 metres (at 5 metres above ground) with 2-3 metres reduction for higher branches (up to 10 metres above ground) Tree 2 (front garden) reduce length of branch over road at 5 metres above ground by 5 metres Tree 3-5 Crown lift to max 4-5 metres from the ground (15% of branches) for Mr F Sims.

<u>TW/22/0076</u> - **17 Barcombe Avenue** - Proposal: T1-T3 - Holme Oaks - Pruned by 3-4 meters and crown raised T4 - Holme Oaks – Fell for Miss D Williams.

Public Participation:

- 5. When the Chair has indicated that it is the part of the meeting that allows public participation, raise your hand and the Chair will invite you to speak in order.
- 6. Statements by members of the public are limited to four minutes and you don't automatically have the right to reply. The Chair may have to cut you short if you overrun on time or try to speak out of turn this is just to ensure the meeting stays on track.
- 7. Where required, the Town Council will try to provide a response to your statement but if it is unable to do so at the meeting, may respond in writing following the meeting.
- 8. Members of the public should not speak at other points of the meeting.
- 9. A summarised version of your statement, but no personal details, will be recorded in the minutes of the meeting.

1. Introduction

- 1.1 The SDNPA is carrying out further consultation on the application by East Sussex County Council originally submitted in April 2021 for the replacement of the A259 Exceat Bridge
- **1.2** The full description of the application is: -

The realignment and replacement of an existing single lane bridge at the A259 over the river Cuckmere, with a new two-way, two-lane bridge with a footpath, including reprofiling of the river and road embankments. Proposed provision of traffic calming measures between the Seven Sisters Country Park and Seaford. Alterations to access and provision of shared surface to east of Cuckmere Inn. Provision of a habitat creation area to restore

agricultural land back into wetland on the east bank of Cuckmere Valley.

The application is supported by an Environmental Statement.

2. The Proposals

- 2.1 The scheme is very much the same as that considered at the meeting on 25th May 2021; the delay and re-consultation arises from a request to the applicants for the submission of additional environmental mitigation measures. These have been supplied in an addendum to the Environmental Statement.
- 2.2 The additional measures are set out in detail a highly technical report from the team of consultants working on behalf of ESCC. The report was posted on the SDNPA applications website on 27th September and outlines an alternative bespoke approach to achieving Biodiversity Net Gain through the project. A non-technical version was posted on the site on 5th September.

3. Previous Response

- When the Committee considered the application last May, it was resolved to support the scheme subject to:-
 - (a) Consideration of the provision of a controlled pedestrian crossing
 - **(b)** Further consideration to separation of cyclists and pedestrians
 - (c) Weight restrictions on the bridge so as to prevent use by HGVs and ensure that HGVs use the designated route to and from Newhaven Port via the A26 and A27.
 - (d) Longer term considerations to be given to a shuttle bus service from Seaford Station to promote the use of rail transport for visitors, relieve the number of cars travelling to and from the Country Park from Seaford and relieve congestion in Seaford town.
 - (e) Welcoming not having bus laybys in order to provide a form of traffic calming and to ensure the free flow of buses.
 - **(f)** Consideration of a 20mph speed limit rather than 30mph, on account of number of pedestrians.
- 3.2 Since the consideration of the application in May 2021, there has also been concerns raised generally about the A259 in Seaford and, in particular, the stretch of the road from the Seaford boundary down to the Exceat Bridge where there is an incomplete and ill-defined path. Complaints have been

received about the difficulties in using this path which is eroded and overgrown in places. Members may wish to refer to this in the discussions, taking into account the anticipated increase in traffic flows.

4. The Re-Consultation

- 4.1 The main significance of the re-consultation is that it gives members the opportunity to consider the objections posted on the SDNPA site since their initial consideration of the scheme.
- 4.2 Members will be particularly interested in the detailed objections from cycling organisations such as Sustrans and the submission from the Seaford Environmental Alliance. These objections echo the concerns of the Committee over the separation of vehicles and cyclists on the crossing and general highway safety.

1. Information

- **1.1** Lewes District Council has received three recent applications for the temporary closure of local roads.
- **1.2** The first application is for **Remembrance Sunday** on 13th November 2022.
 - (a) The roads affected are:
 - i. A259 Clinton Place roundabout to junction with Southdown Road;
 - ii. Broad Street from junction with Clinton Place to junction with Sutton Road;
 - **iii.** Place Lane from junction with Church Street to junction with Broad Street;
 - iv. Avondale Road around War Memorial.
 - **(b)** The closure requested is from 10.00 to 11.40.

- 1.3 The second application is for the Tour of Sussex 2023 cycling event on Sunday 7th July 2023.
 - (a) The closure requested is the Esplanade from east of the junction with Dane Road to the junction with Martello Road.
 - (b) A similar event for 2022 was cancelled. Prior to that event there were negotiations with the organisers over the extent of the closure. The proposed closure in this application reflects the agreed proposals for the cancelled 2022 event.
 - **(c)** The closure is requested from 13.00 to 21.00.
- 1.4 The third and final application is for dates for the regular Seaford StreetMarkets from 11th February 2023 for the remainder of 2023.
 - (a) The dates of the markets are (all 2023) 11th February, 25th February, 11th March, 25th March, 8th April, 22nd April, 13th May, 27th May, 10th June, 24th June, 8th July, 22nd July, 12th August, 26th August, 9th September, 23rd September, 14th October, 28th October, 11th November, 25th November, 9th December and 23rd December.
 - **(b)** The market closures will cover Church Street from south of the junction with West Street to the Crypt Gallery.
 - (c) The closure is requested from 0700 to 1800.
- **1.5** Members are requested to consider the applications and forward any comments to Lewes District Council.
