Public Participation:

Below are some key points for public participation in the meeting:

- 2. You will only be able to speak at a certain point of the meeting; the Chair of the meeting will indicate when this is.
- 3. You do not have to state your name if you don't want to.
- 4. If you are unsure of when best to speak, either query this with an officer/councillor ahead of the meeting or raise your hand during the public participation item of the meeting and ask the Chair they will always be happy to advise.
- 5. When the Chair has indicated that it is the part of the meeting that allows public participation, raise your hand and the Chair will invite you to speak in order.
- 6. Statements by members of the public are limited to four minutes and you don't automatically have the right to reply. The Chair may have to cut you short if you overrun on time or try to speak out of turn this is just to ensure the meeting stays on track.
- 7. Where required, the Town Council will try to provide a response to your statement but if it is unable to do so at the meeting, may respond in writing following the meeting.
- 8. Members of the public should not speak at other points of the meeting.
- 9. A summarised version of your statement, but no personal details, will be recorded in the minutes of the meeting.

1. Information

- 1.1 Seaford Town Council has been notified of an application to Lewes District Council for temporary road closures for the 'Walk the Chalk' event taking place in Seaford on Wednesday 20th September to Sunday 24th September 2023.
- **1.2** The application is from the organisers LYT productions. The proposed closures are in Chyngton Way, from its junction with Lullington Close to its junction with Chyngton Lane.
- 1.3 Walk the Chalk is a five-day walking festival celebrating the newly renamed King Charles III Coastal Path. It is specifically aimed at the local community who do not usually access green spaces or the path but it is open and fully accessible to all.
- 1.4 The Town Council has been involved in discussions with the organisers regarding the running of the event and Full Council was briefed on the event at the meeting on 20th July. The report is therefore largely for the information of members and the Committee is recommended to note the report.

The Committee is recommended:

1.To note the details of the Local Development Scheme and contents of this report.

1. Information

- 1.1 Lewes District Council has published a revised Local Development Scheme; essentially a timetable for the remaining stages of the new Local Plan up to final adoption.
- The full text of the scheme is accessible on the link below
 Local Development Scheme Appendix 1 (lewes-eastbourne.gov.uk)
- **1.3** The new scheme updates the previous scheme dated July 2020 and covers the parts of the District outside the South Downs National Park.
- 1.4 As the new scheme points out, one of the difficulties faced by authorities currently drawing up local plans and the reasons why the process is relatively slow, is that government legislation specifying how plans should be drawn up and what they should contain has been slow in coming forward.

- 1.5 Paragraph 3.2 of the scheme confirms that, in these circumstances, the Local Planning Authority can only operate under the current rules; proposed changes to those rules in the Levelling Up and Regeneration Bill, which have been under consideration in both Houses of Parliament for some time, cannot be implemented until the Bill is passed and receives Royal assent.
- 1.6 Therefore, as the text at the end of Paragraph 3.2 confirms: 'The Local Planning Authority continues to prepare planning policies under the current system whilst monitoring the progress of these proposed changes.'
- 1.7 The scheme has been published in accordance with legal requirements and for the information of interested parties, residents, developers, landowners and town and parish councils.
- **1.8** There is no formal consultation exercise regarding the scheme and the Committee is therefore recommended to note the scheme and this report.

1. Information

- 1.1 East Sussex County Council is carrying out consultation until 25th September on its Bus Service Improvement Plan (BSIP)
- **1.2** The aims of the BSIP are to:
 - (a) Improve the reliability and punctuality of bus services and explore methods to make bus services more accessible
 - **(b)** Encourage an increase in the proportion of people travelling by bus
 - **(c)** Enhance the bus network, reducing journey times and improving reliability and punctuality of bus services
 - (d) Increase bus usage across the county by building a bus network that meets everyone's needs

- **(e)** Complement and support wider transport investment across the country.
- 1.3 There are no measures in the BSIP affecting Seaford directly but there are significant proposals for Newhaven, Peacehaven and Eastbourne, that will impinge on Seaford residents in some way or other.
- 1.4 The Newhaven and Peacehaven proposals are clearly aimed at speeding up the flow of the number 12 Brighton/Eastbourne buses through the towns and along the A259.
- 1.5 The main point of interest in the Eastbourne proposals, is the planned dedicated bus lane in Kings Drive in the area of the District General Hospital
- 1.6 The full proposals are set out in the brochure accessible on the link below.

- **1.7** The Committee is recommended to consider the proposals and agree and submit any comments to East Sussex County Council.

LW/23/0371 – 5 St Wilfred's Place - Single storey rear extension and single storey side/rear infill extension.

LW/22/0739 - Seaford Town Football Club, The Crouch, Bramber Lane

Amended description: Vary condition 1 of planning permission LW/10/0783 to permit up to 22 floodlit matches. Restriction on latest time of use to remain the same at 21:50 hours.

Approved subject to the following conditions:

- The floodlights hereby approved shall be used for up to a maximum of twenty two (22) competitive evening games per football season (August June).
- The Club shall provide advance written notification to the local planning authority of the dates when the 22 evening games are to be played.
- On each of the 22 evenings when games are played the floodlights shall not be illuminated after 9.50pm or after the completion of the competition event, (but only for the event purposes of "extra time or penalties" and not for any other purpose) and in any case with an absolute end of illumination on such occasions of 11pm.

Reason: To help safeguard nearby residential amenity, having regard to policies CP10 and DM25 of the Lewes District Local Plan and the NPPF

- The floodlights hereby approved shall not be used for any purpose on Sundays, Bank or Statutory Holidays. Reason: To help safeguard nearby residential amenity, having regard to policies CP10 and DM25 of the Lewes District Local Plan and the NPPF.
- A maximum of four floodlight columns only shall be used on training sessions. On each of those evenings when training takes place the floodlights shall not be illuminated after 9pm.

Reason: To help safeguard nearby residential amenity, having regard to policies CP10 and DM25 of the Lewes District Local Plan and the NPPF.

LW/22/0740 – Seaford Town Football Club, The Crouch ,Bramber Lane

Various business advertisement boards fixed to the pitch side barriers, fascia signs to the football stand. Subject to the following specific conditions:

This consent shall expire 5 years from the date of this notice [8th August 2023]
 whereupon the signage shall be removed and any damage repaired unless further consent to display has been given by the Local Planning Authority.

Reason: To accord with Regulation 14(7) of the Town and Country Planning (Control of Advertisements) (England) Regulations 2007 and for the purposes of amenity and public safety.

- No further adverts will be added to the ground. No adverts will be externally or internally illuminated.
- No further adverts will be installed without advertisement consent.
- A photographic and positional plan record will be made of the existing adverts on the football stand and pitch barriers and submitted to the Planning Authority within 1 month of this permission.
- All Advertisement fixings to also be agreed in writing by the Local Planning Authority to ensure they are secure.

Reason: To comply with LP 2 DM31 policy on Advertisements and to ensure public amenity and safety .
