## F35/03/24 Receipts, Payments and Bank Reconciliation Reports for December 2024 and January 2025

# F36/03/24 Finance & General Purposes Finance Report for 1<sup>st</sup> April 2024 to 31<sup>st</sup> January 2025

The Committee considered report 173/24 presenting the income and expenditure for 1<sup>st</sup> April 2024 to 31<sup>st</sup> January 2025 and highlighting significant variances from budget. It was **RESOLVED** to **NOTE** the contents of the report.

#### F37/03/24 Policy Update - March 2025

The Committee considered report 179/24 providing the Committee with an update on the 2024 – 2025 work schedule with the Town Council's policies.

Members discussed ensuring that report text can be differentiated on printed copies of agendas, and how it is determined which committees will consider future policy reviews under the revised committee structure.

It was **RESOLVED** to **NOTE** the contents of the report.

#### F38/03/25 Review of Town Council's Financial Regulations

The Committee considered report 130/24 presenting the updated Financial Regulations based on the new model template issued by the National Association of Local Councils. Members discussed a number of proposed amendments and clarifications which officers will look into and be included in the final version being presented to Full Council for consideration.

It was **PROPOSED** to **RECOMMEND** the updated Financial Regulations for adoption by Full Council, subject to officers looking further into the comments raised by Committee including the addition of the Evaluation process and making the necessary amendments for presenting to Full Council; the **MOTION** was **CARRIED**.

### F39/03/24 Introduction of a Whistleblowing Policy

The Committee considered report 181/24 seeking the Committee's feedback on the draft Whistleblowing Policy and recommendation to Full Council.

Members discussed including a hierarchical table to ensure clarity about the handling of the process and whether the policy covers councillors that have concerns about wrongdoings. (7.41pm – Councillor L Boorman exited the meeting)

It was **PROPOSED** to **RECOMMED** that Full Council adopts the Whistleblowing Policy with immediate effect, subject to a hierarchical table being added as an addendum to the policy; the **MOTION** was **CARRIED**.

### F40/03/24 Seaford Town Flag

The Committee considered report 178/24 presenting the Committee with the final design and costs for the Seaford Town Flag, to be gifted to the town in celebration of Seaford Town Council's 25th anniversary.

Members discussed the Latin motto, the reasonable cost, the flag being for Seaford Town, the mirror image logistics, and the need for a civic protocol for use of the flag and permitting use by others.

**F40.1** It was **RESOLVED** to **AGREE** the Seaford Town flag design.

F40.2 It was RESOLVED to AGREE the proposals for the town receiving and flying the Seaford Town Flag.

#### F41/03/24 Exclusion of the Press & Public

It was **RESOLVED** that in accordance with the Public Bodies (Admission to Meetings) Act 1960, the press and public **BE EXCLUDED** from the meeting during the discussion on the next item of business for the reasons as set out on the agenda.
