P44/12/25 Apologies for Absence

Apologies for absence were received from Councillor L Wallraven (Cllr I Taylor substituting).

P45/12/25 Disclosure of Interests

Councillors O Honeyman and R Honeyman declared a non-pecuniary interest in application LW/25/0638 due to knowing the applicant in a personal capacity but that they would continue to take part in discussion and vote.

P46/12/25 Public Participation

There was no public participation.

P47/12/25 Planning Applications – For Comment

Planning Applications received in week commencing Monday 3 November 2025

LW/25/0649 – 7 Hartfield Road – Replacement of existing conservatory with single-storey rear extension.

It was **RESOLVED** to **NOT OBJECT** to the application.

Planning Applications received in week commencing Monday 10 November 2025

LW/25/0666 – 89 Sutton Drove – Addition of 1no. front and 1no. rear dormer.

It was **RESOLVED** to **SUPPORT** the application as the proposals are in keeping with the neighbourhood.

Planning Applications received in week commencing Monday 17 November 2025

LW/25/0638 – Land to the South of Florence House Southdown Road – Erection of 7.no dwellings including accesses, landscaping and other associated infrastructure

It was **RESOLVED** to **SUPPORT** the application, highlighting to the Planning Authority that this new development would be ideal for the inclusion of swift bricks or swift boxes to enhance biodiversity.

LW/25/0672 – 10 Cornfield Road – Raising of existing side boundary brick wall with wooden fencing to 2m, and erection of 1m sleeper wall to front/side boundaries

It was **RESOLVED** to **NOT OBJECT** to the application.

Tree Works Applications

TW/25/0101/TPO – 1 Chapel Close – T5 - Beech - Reduce secondary growth by 25% at the front; lift smaller growth on North side to approx. 6m; and reduce branch length by up to 4m (13ft) - to reduce overshadowing and provide better balance for the tree

It was **RESOLVED** to **SUPPORT** the application.

TW/25/0114/TPO – 7 Roedean Close – G5 - 8 No. Sycamores - Crown reduction by 2 metres - General maintenance to reduce growth towards highway.

It was **RESOLVED** to **SUPPORT** the application.

TW/25/0116/TCA – 10 Blatchington Hill – T2 - Italian Plum - Crown reduction and reshape by up to 2.0-2.5 m T3 - Red Horse Chestnut - Crown reduction and reshape by up to 2.5-3.0 m to growth points - Remove deadwood and stubs in crown.

It was **RESOLVED** to **SUPPORT** the application, adding a reminder that the applicant should adhere to pruning seasons, in this case being Summer for the Italian Plum (to prevent silver leaf disease) and late Winter to early Spring for the Red Horse Chestnut.

TW/25/0121/TPO – 19 Normansal Park Avenue – T1- Elm - Removal to ground level and bark stripping of remaining stump due to Dutch Elm Disease

It was **RESOLVED** to **NOTE** to the Town Council's application.
