**C48.5** It was **RESOLVED** to **DELEGATE** power to the Town Clerk to prepare and execute the required licence to occupy with South Downs National Park Authority prior to works starting on site.

**C48.6i** It was **PROPOSED** to **DELEGATE** power to the Town Clerk to draft a management and maintenance agreement with Seaford Community Partnership to maintain the asset following completion, to return to Full Council for approval; the **MOTION** was **CARRIED**.

**C48.6ii** It was **PROPOSED** that the draft management and maintenance agreement be drafted without any financial outlay to the Town Council; the **MOTION** was **NOT CARRIED**.
